In connection with the dividend payments of \$0.0387, \$0.029 and \$0.042 per common share (ex dividend date August 1, 2017) payable on August 1, 2017 to shareholders of record on July 31, 2017 of the Class A, Class C and Institutional Class shares, respectively, it is anticipated that 36% of such dividend will be a return of capital, 64% ordinary income (including short-term capital gains) and 0% long-term capital gains. The amounts and sources of distributions reported in this Section 19 Notice are only estimates and are not being reported for tax reporting purposes.
